Attached are our edits on the population forecasts, thanks for inviting cities to weigh in. Ideally this paper won't be finalized until after the 3/28 community informational meeting with OFM and Commerce, which may shed more light on this issue.

The edits are intended to more completely list the WAC direction on this issue, flesh out the policy implications of the forecast a bit, add background on annual growth rates, add information on OFMs track record, discuss rules and implications of future adjustments, and flesh out the HB 1220 housing requirements and ties of that to the population.

We will follow up on the employment side next week.
