Futurewise works throughout Washington State to support land-use policies that encourage healthy, equitable and opportunity-rich communities, and that protect our most valuable farmlands, forests, and water resources. Futurewise has members and supporters throughout Washington State including Clark County.

Thank you for the opportunity to comment on the 20-year population projection for the 2025 Comprehensive Plan update. Futurewise recommends the County adopt the “middle” or “medium” population projection. That projection is the most accurate. For example, the 2017 medium population projection was just 3,911 people, -0.8 percent, below the 2020 census population for Clark County.<sup>1</sup> The 2017 high population projection was 46,653 people, 8.5 percent, higher than the

2020 census population.<sup>2</sup> The Office of Financial Management first prepared Growth Management Act population projections in 2002, and also prepared projections in 2007, 2012, 2017, and 2022. For the four sets of projections that were done before 2020, the medium, or middle, projection has always been the most accurate for Clark County.<sup>3</sup>

Efficiently providing public facilities and services is important in Clark County because the current County Comprehensive Plan Transportation Element projects a 20-year deficit of -\$158,104,000.<sup>4</sup> Given this deficit, planning for a higher than needed population projection will just increase costs for taxpayers and ratepayers because they will need to fund unneeded public facilities.
