Thank you again to those who joined us on the 14th for our meeting on Phase 2 of the Climate Pollution Reduction Program (CPRG). We are grateful for all the questions and look forward to working with you as we continue to strategize on how best to meet our State and region's climate goals. In follow-up to our conversation, we are sending the link to the survey we discussed in our meeting on the 14th. - 1. Coalitions and partnerships among entities will make Phase 2 applications more competitive.
- 2. Coordination amongst Washington eligible entities will ensure greater opportunity for success and Commerce and PSCAA are here to help.
- 3. While CPRG can't fund all projects or programs we identify, it's also not the only funding source for our climate priorities. We can help identify federal and state funding that can support these important measures beyond CPRG funding.
- 4. Commerce and PSCAA must know which entities are submitting Phase 2 applications so that we can include the relevant GHG measure in our respective Priority Climate Action Plans (PCAP's), We aim to identify Phase 2 applications by mid-January 2024.
