Hello Marina.

My name is Bart Catching. I work in Community Planning (long-range planning) for the county. As you know, your property is five acres in size and is zoned AG-20, which is a resource zone, with a comprehensive plan designation of AG. You would not be able to subdivide the property under current zoning.

Resource zones cannot be changed to non-resource zones on an individual property basis, but rather through a county-wide evaluation. Generally, such changes are considered through the comprehensive plan periodic update process that our department is working on right now and is scheduled to be completed in September 2025. The process available to you as a property owner to submit a site-specific request for a rezone to be considered during the comprehensive plan update is to submit a public comment describing your request. The comment will become part of the public record and will be analyzed along with other site-specific requests during the plan update. This is not a guarantee of any plan or zone change on your property, but it will indicate your desire for county council consideration during the plan update process.
