Hi Erin –

I understand you are interested in the proposed housing code amendments. The phase 1 (middle housing/single-family) batch of code and comprehensive plan amendments were presented to the County Council on July 25. At the hearing, council requested staff and our consultants to complete additional work on the phase 1 proposal with review and consideration by the Technical Housing Code Forum.

To meet this request, staff is working with the consultant to prepare additional materials for discussion, based on Council direction. The first forum meeting has been scheduled for **October 5**,

2023 from noon to 2 p.m. Please see this webpage for additional details and a link for the virtual meeting: <https://clark.wa.gov/community-planning/housing-options-study-and-action-plan>. We will be posting the materials for the October 5 meeting on that webpage later today. That webpage also has all of the materials that were considered in the hearing on July 25, and information about previous Technical Housing Code Forum meetings including links to all of the related materials.

There is a second phase of the work regarding multi-family and regulated affordable housing strategies. To allow time to accomplish the work on the phase 1 portion of the project, we are pausing work on phase 2 for the moment. We plan to schedule the next phase 2 meeting of the Technical Housing Code Forum later this year.
