Perhaps it could be a pilot project with the understanding that the code will need to be adopted prior to the application being accepted and that the preapp comments are based on draft code and subject to change. It could be a good way to test out the code so we have a chance to make adjustments if necessary prior to adoption. It may also help spread out the workload.
