Hi Vicki –

This is a response to the question you sent to Marilee McCall below regarding the Housing Options Study and Action Plan presentation to NACCC last night. I did a review of development proposals from the last several years in the county jurisdiction and unfortunately didn't find anything applicable. I reached out to a few contacts and got the following responses and contact suggestions:

Vancouver Housing Authority

Fort Vancouver, Azalea Place, and Cherry Park are VHA's developments that serve the IDD community. Those who are interested are able to add their name to the waitlists for these properties on the VHA website (www.vhausa.com)

There has been an increase in dedicated funding for the IDD population, however, we at VHA have not developed a new development for this population in sometime. VHA is in the process of developing a housing strategy and have had preliminary meetings with organizations that work closely with the IDD community to determine how VHA could best provide assistance.
