Dear Councilors,

The attached notice came from the Food System Council, an affiliate of Friends of Clark County. CCCU attended this event,, much by accident, and were alarmed to see that it was, for the most part, an environmentalist and Futurewise presentation, using the Food System Council as a front. This event was paid for by Clark County tax dollars. County staff members, including Gordy Euler, were in attendance and helping to facility the event. They provided fliers, documents and maps to support the groups presenting there, which consisted of FOCC members and supporters, along with a Futurewise presenter.

This is the event that Mr. Euler argued with CCCU regarding metadata for GIS resource maps. He insisted that CCCU's GIS maps didn't have metadata, while Clark County GIS maps did. That conversation put CCCU on the track to finding the GIS metadata that proved that Clark County lied in their documents about using the NRCS manual to determine resource land in the Clark County Comprehensive Plan. The only metadata to explain how resource land was determined was a document that clearly stated, to determine resource land, the county used "aerial photography and staff interpretation" exclusively. That 1993 document is the only metadata that explains how the existing resource maps in the 1994 Comprehensive Plan were created. The photos that were used, were destroyed, along with the original resource committees minutes and notes of their meetings. Even though CCCU asked for a supplement of the record, in 1994, to retrieve those photos and records, Rich Lowery, attorney for Clark County, refused to submit them, and claimed it was no longer possible to find them in the record.

Since the discovery of that information, that metadata document has been removed from the GIS data base and replaced by a document that is vague, at most, and does not describe what happened at that time, in 1993. But CCCU has clear copies of original metadata, and have submitted the document into the public record.
