Hello! I attended the first hour of the zoom meeting on climate planning - thank you all for your vision, concern, and service!

I wasn't able to attend the whole meeting, so perhaps this came up, and perhaps I'm jumping the gun, so please excuse me if that's the case. My concern is this: I didn't notice, during the discussion of the many groups disproportionately impacted by the climate emergency, any mention of the disability community or the neuro-diverse, who are often infantilized and dismissed. I also wanted to suggest that as the knowledge of the climate crisis becomes more widespread and dire, the mental health of our children, and the public in general, will become more fragile. Not only will we all experience the suffering of the chaos brought by those changes physically, but we will all need to rely on our civic and other organizations and professionals to help us emotionally, spiritually, and even cognitively.

I dearly hope that our community will be transformed by creativity, hope, and imagination in addressing the urgent needs of the day. I saw yesterday in the meeting that the climate plan will be informed by the inclusion of the shining, collaborative minds of our vulnerable communities, which fills me with hope. Finally, I fiercely wish that we will be able to quickly protect our children's mental health by empowering them to hope, to love this beautiful natural world of which we are part, and invigorate them to take their first independent steps into the wider world with confidence in their ability to make a contribution to the vital and quick actions we must take.

As I said at the top, perhaps my comments are redundant, or directed to the wrong group. If that's the case, then oops! I just feel compelled to speak my truth.
