As a resident of Clark County in the 18th Legislative District, resident in County Council District Number 2 and currently serve as an appointed precinct officer for precinct 638, I request that the County Council suspend the decision to spend 100,000 dollars of taxpayer money to Berk Consulting and the plan to implement the FRDU SB 5517.
