In G21 P2 : Public transit should include "Regional Passenger Rail." Regional Rail is different from "Commuter Rail" since Regional Passenger Rail travels both directions during the day. Whereas Commuter Rail travels one direction in the morning and the other direction in the afternoon. Also Regional Passenger Rail trains use the same tracks as Freight Rails so it is cheaper to implement than Light Rail Transit. Rail travel is environmentally friendly and can be faster than auto travel.
