What: Over the next year, Washington state will be developing a Comprehensive Climate Action Plan (CCAP) to meet state and federal climate and energy mandates. We are forming a [CCAP advisory committee](#) to advise lead agencies (Department of Commerce and Department of Ecology) on CCAP development, engagement, and content.

Why: Climate change impacts everyone. We are committed to extensive and meaningful engagement with partners and communities across the state in the development of this Comprehensive Climate Action Plan to quickly and equitably achieve Washington's climate goals. This advisory committee will help facilitate connections and elevate the voices of communities and impacted groups across the state throughout plan development.

Who: We are looking for 7-15 people with a broad range of experience, perspectives, and interests. The advisory committee will include at least one member to represent the following perspectives:

- Underserved or disadvantaged community/communities
- Tribal government or organization
- Local governments (city or county)
- Labor organizations
- Private sector
- Industry/manufacturing
- Port authorities
- Other perspectives that may be considered for the committee include climate/environmental advocacy groups, utilities, academia, sector-specific experts, etc. or others not listed.

Where/When: The committee will meet virtually once a month (exact time TBD) until the CCAP is published in July 2025.

Deadline: Has been extended until 8/9/2024 applicants will be notified by the end of August.
