Clark County Citizens United, Inc. is voicing concerns over the Covenant language that was adopted by the Council for the Heritage Farm. It has no teeth, and opens the land to anyone and everyone. CCCU has copied and pasted the document, and highlighted text which we believe must be removed from the Covenant, to make the Farm a public entity that will serve the public for years to come.

Surely the Councilors noticed the open language of the text, before they adopted it. It states, "and any future owners of said parcel..." The one and only "owners" of the land is supposed to be Clark County, Washington. There should not be "future owners", even considered or mentioned in the text.

It also states, "and/or its assigns and successors in interest into whose

ownership said property may pass,". The one and only owner of the property is Clark County and the land should not be passing to any assigns and successors, that the ownership would pass. That text needs to be removed.

This Covenant does not accomplish the preservation of the land for permanent future public use, and needs to be corrected, if in fact the goal of preserving the Farm was for the public and the reason for the Covenant, it needs to read as such. But as it is written, it doesn't.
