Comments

I am strongly opposed to adding a surface mining overlay to parcels 247859000, 247860000, 247860000, 247849000. Adjacent to these parcels are homes with children, timberland, important wildlife and natural water sheds. Residential zoning for this area (and parcels size rules) were established to provide a clean, safe residential environment. Breaking zoning rules for an individual corporation makes a mockery of zoning and the initial purpose of zoning regulations. In addition, any mining in this vicinity is detrimental to the people, homes, wildlife and overall beauty and character of the adjacent area to have blasting and traffic hazards connected to a mine on the forementioned parcels. Sunset Falls Road, as part of the Molten Falls recreational, protected area, cannot support mining traffic.
