Mr. Cruz,

The request to change the zoning from Industrial to Commercial was not included in the alternatives to study as part of the environmental impact study (EIS). The proposal does not align with the amendments being proposed as part of the 20-year comprehensive plan update. The property is surrounded by Industrial and Business Park designated property and would likely be a spot zone if it were to move forward. In addition, there are additional commercial zoned properties to the south along NE 10th and NE 179th St. and in the general vicinity.

The Council will have a hearing on Friday December 6, 2024, at 9am to determine what goes forward to be studied in the EIS and you're welcome to attend and/or submit public comment to advocate for the inclusion of the property.

The final decision on any zoning or comprehensive plan changes will not occur until the end of next year and will be made by the County Council.
