Dear County Manager Otto,

Clark County Citizens United, Inc. is sending you this attached email response from county staff, which is commonly received by rural landowners as they question regulations they feel are unreasonable. In the wetland and habitat permitting, it is common throughout. When this happens, the appeal time runs out. The landowner is tricked into believing they can have meaningful communication with staff, but that seldom happens.

You have been sent and should have received all of the testimony regarding their concerns, continuously, as they are sent to the councilors. Yet, nothing is done about the problem and no response is received by the landowner or CCCU, from county agents. CCCU has been told that only you have the power to do anything. If that is so, then your position should be an elected position, and not an appointed one. But regardless, a close monitoring of the staff activity, should be in order.

As the county manager of all of Clark County, it is your responsibility to assure that all county citizens are treated equally and fair by county staff. We ask that you take that charge seriously, and help these landowners, who are burdened with unfair, onerous and unreasonable regulations, Councilor Marshall was given that benefit, when she divided the Bauer land in 2014-2015. Planning Commission member, Barca also was given a buffer break when he developed his land next to a Type F stream, while his neighbor was hit with 200 feet. Neither Barca or Marshall/Bauer were required to sign a permanent covenant on their land. Something is very wrong here. CCCU understands that only you can fix it.

CCCU asks that the covenant language be voluntary, and not mandatory. The mandatory language needs to be removed from the Wetland and Habitat Ordinance, retroactive to 2008.
