This policy that I edited was given a score of 2a, substance concern, discuss. Community feedback was incorporated in the editing of this policy.

G19- P9

Collaborate with C-Tran, Tri-Met, Community in Motion, city and regional partners, local employers, and community-based organizations to provide education, marketing, and incentives, including expanded free transit for students of all ages and offering "frequent flyer" type incentives. This aims to encourage the habit of using transit, build ridership until buses are full, and prioritize overburdened communities by removing barriers to accessing these services.

Explained in simple terms:

The plan is to work together with various groups like transportation companies (C-Tran and Tri-Met), local businesses, and community organizations. The goal is to teach people about public transportation, promote it, and offer special deals, such as free bus rides for students and rewards for regular users. This will help more people use the buses, especially those who might find it hard to access these services. By doing this, we want to make sure that buses are busy and that everyone, especially those in need, can easily get around.

Jessica Brown's comment was about expanding the counties recycling program to include plastic clam shells. I am advocating for plastic policy and I'm bringing this up because another CAG member is also concerned about plastic. The score was given a 3b, outside of scope, but with the resources that I've been providing, it actually fits within the scope of greenhouse gas reductions and resiliency.

My comment was given a 3e, consistent with existing wording but I'm not finding schools on the list. Is there another word that defines schools? Because I see households, businesses, county-led programs and community-based programs.

I would like to see sustainable packaging and low carbon construction materials as a requirement. Not just saying prioritize. I'm okay with saying prioritize goods locally since we cannot always find local products.

My comment was given 3g, staff don't recommend for another reason not listed here

We will empower decentralized, participatory decision-making structures, such as citizens(community) assemblies and commons-based resource

management, leveraging the collective intelligence of local communities. By fostering collaborative education and actively engaging with experts, we will enhance the capacity and technical expertise of local government staff in climate change and environmental justice. This approach ensures continuous improvement in community-wide policy, equitable implementation, and resilience, promoting a robust framework for effective governance.

Conduct a 2 and 1/2 year check-in to identify implementation progress, successes, and barriers, providing immediate support as needed to inform priorities for the next 5-year cycle.
