By using "a high level of accessibility," we emphasize the goal of meeting a significant portion of needs without specifying numbers, which aligns with the community's preference.

Here's a revised version of our policy incorporating "a high level of accessibility":

"Provide connected and accessible communities in the unincorporated Vancouver urban growth area where most daily needs can be met within a convenient and safe walk, ride, roll, or transit ride by planning for amenity-rich activity centers and corridors, areas of dense, mixed-use urban development, neighborhood-scale commercial opportunities, and safe connections between destinations, ensuring a high level of accessibility for residents."

Using "majority" indeed emphasizes a stronger commitment to meeting community needs and provides clarity. However, since we are aiming for a term that conveys an even higher standard, we might consider using "significant majority" or "vast majority." These phrases imply a higher threshold (often interpreted as around 80% or more) while still maintaining clarity.

Here's a revised version of our policy incorporating "significant majority":

"Provide connected and accessible communities in the unincorporated Vancouver urban growth area where a significant majority of daily needs can be met within a convenient and safe walk, ride, roll, or transit ride by planning for amenity-rich activity centers and corridors, areas of dense, mixed-use urban development, neighborhood-scale commercial opportunities, and safe connections between destinations."

This wording strengthens the intent and creates a clear expectation for the community's accessibility, aligning with our goal of impactful planning.
