Hello,

I'm a Clark County resident and very interested in a Comprehensive Plan provisions that you all will be voting on tomorrow. I can't attend the meeting to testify in person. But I would like to express an opinion on a that issue.

I'm concerned about Clark County RESOLUTION NO. 2025-04-xx. I urge you to pass the resolution AS IS. I support the Resolution omitting options from the Comp Plan DEIS that would require the de-designation of resource lands or surface mining overlay designations, as well as discontinue the countywide resource lands study.

I'm very concerned about climate change issues and appreciate the fact that the Comprehensive Plan must address climate issues. However, by including resource land de-designation scenarios in the DEIS, I think Council would be ignoring its obligations to act on the climate emergency, specifically, reducing sprawl, addressing transportation, protecting and enhancing the environment, considering open space and recreation and protecting natural resources.

There's no reason to take a different approach. The Council has already informally endorsed the best path forward for the Comp Plan DEIS. Adopting the Amended Resolution as drafted will be consistent with the Council's unanimous agreement on March 5, 2025. Please pass the Amended Comp Plan DEIS Resolution as drafted and without revisions that will jeopardize the County's ability to effectively address climate issues.

Thank you for considering these comments and for your efforts to include effective climate measures in the Comprehensive Plan.
