Please approve the Amended Resolution contained in Separate Business item #2, which would omit options from the Comp Plan DEIS that would require the de-designation of

resource lands or surface mining overlay designations as well as discontinue the countywide resource lands study, AS IS.

Performing a resource lands study does sound like an important next step, but to hastily tack it onto the Comp Plan is extremely irresponsible. Upon successful completion and submission of the Comp Plan, a resource lands study could be organized and started. But a good one will take years to be full and comprehensive; trying to justify knocking one out in less than 3 months is, again, suspiciously irresponsible.

Once resource lands have low-density housing subdivisions, etc., built on them their efficacy as a resource land is forever diminished, if not ruined. We should be more intentional about preserving a critical mass of agricultural lands in the County. We can't eat housing. There are plenty of lands within the UGA that are underutilized and could be more responsibly developed rather than hunting down the next set of farmer's fields for inefficient, infrastructure-intensive, development.

I am not anti-growth, but I am anti-sprawl. And I am pro-farmer, pro-rural, pro-open space, and pro-revenue. Please approve this resolution and be responsible; there is more to the County than the housing crisis.
