Dear Clark County Council,

We are a coalition of community-based organizations advancing equity and uplifting the voices of historically and systemically underserved communities in the public process for the Clark County Comprehensive Plan. We are deeply concerned and disappointed in Councilmembers Belkot, Little and Yung for voting to complete a rushed agricultural land study. We urge Council to prioritize the housing equity and climate requirements of the Growth Management Act (GMA) in the Comprehensive Plan, for the future of all County residents.

Equity and Climate Resilience are At Stake

Delaying the Comprehensive Plan means the County Council will likely be out of compliance with the Department of Commerce. This will have damaging financial consequences and jeopardize funding needed for essential housing and environmental justice policies to protect community health, safety, equity, and climate resilience.

Relevant policy suggestions were developed with local community members. Abby Hollopeter of Odyssey World International Educational Services, Monica Zazueta Tabor of Vancouver Metro LULAC Council, Gabriela Ewing of Pasitos Gigantes and Minh Pham of Vietnamese Community of Clark County served on the County's Environmental Justice Coalition (EJC), a body formed to ensure inclusive engagement and integrate marginalized voices into developing climate policies mandated by the GMA.

Equity is deeply embedded in the state-mandated <u>Climate Element</u> in the GMA. The County's decision to spend \$300,000 of taxpayer money on a study County staff advised against due to its rushed timeline —and that the majority of public testimony opposed— is both fiscally irresponsible and fundamentally inequitable. A rushed land study is unlikely to be sufficient, which will leave the County vulnerable to legal challenges.

Follow the Law Regarding Mandatory Elements of Comprehensive Plans

Policies that protect housing stability and environmental justice are not optional—they are required. RCW 36.70A.070 mandates that Comprehensive Plans "identify, protect, and enhance community resilience to climate change impacts, including social, economic, and built

environment factors, that support adaptation to climate impacts consistent with environmental justice."

What We Need in an Agricultural Land Study

Currently, the Comprehensive Plan does not require consideration of food security. However, Land Studies "may consider food security issues." We urge the County Council to require that food security be prioritized in its Ag Land Study.

What We Need in a Preferred Land Use Alternative

We urgently request the County adopt a Land Use Alternative which prioritizes climate, equity and resilience, which our communities know are necessary components of the Comprehensive Plan. We urge you to consider our demands related to climate resilience and equity:

• Preserve agricultural land and all usable farmland for our food security

- Preserving agricultural land will enable people in Clark County to grow their own food and will support local farms. This will improve Clark County's <u>climate</u> <u>resilience</u>, <u>which is required by the Climate Element</u>.
- Preserving ag land will reduce greenhouse gas emissions (GHGs), 67% of which are currently imported in Clark County (28% of these emissions are from imported food)². Lowering GHGs is required by the Climate Element.

Reduce sprawl

Ensure that any land added to the new urban growth boundary is designated for diverse housing types, including duplexes, fourplexes, and multifamily developments and hold all cities within Clark County accountable to actually build diverse housing types and affordable housing. Missing our GMA deadline is egregious because the cities of La Center and Ridgefield, who are pushing for this land study, have historically ignored and continue to ignore the need for equitable, affordable housing within their boundaries. Since 2023, the City of La Center has not issued any permits for multifamily housing construction.

- Reducing sprawl will <u>reduce vehicle miles traveled (VMTs)</u>, which is a required <u>part of Comprehensive Plans</u>.
- Lowering VMTs will improve air quality and community health outcomes throughout the county, particularly for BIPOC and lower-income communities that live by major roadways.
- Prioritize actual affordable housing and infill development over Urban Growth Boundary expansions.
 - Affordable housing is required by the GMA.
- No Urban Growth Boundary expansions for Ridgefield and LaCenter. Clark County
 Council voted to approve population projections provided by the Dept. of Commerce in
 2023. State-provided data demonstrate that all cities within Clark County have enough
 land to accommodate the projected growth estimates that Council adopted.
- Adopt parking reform based on <u>SB 5184</u>, also known as the <u>Parking Reform and</u>
 <u>Modernization Act</u>. Doing so would allow for many more affordable housing units, more child care centers, and more small businesses.
- **Expand tree canopy** in unincorporated Clark County to mitigate urban heat island effects.
- Increase parks to address the County's parks level of service deficit to provide for the well-being of residents. This includes ensuring Clark County is in compliance with the state. The County's own Ross Hoover stated that state funding sources should be part of the parks funding plan.

Let It Be Noted: We Do Not Represent "Special Interests"

In 2024, the Washington Legislature prioritized the participation of historically excluded populations by funding us to engage our communities in Comprehensive Planning. This is why our coalition exists, and why we conducted extensive outreach to ensure their voices were heard. The only special interest our coalition represents is a significant portion of us who have been excluded from participating in governance, who lack the resources for lobbying, and who deserve to be able to call Clark County home for as long as we may choose.

This plan must intentionally support those who have historically, and continue to be, impacted by systemic racism, discrimination, poverty and environmental injustice. Through our

community engagement, it is clear that timely action on affordable housing, climate justice and food security policies is critical. Community members shared with us their increasing fears of displacement and the threat of homelessness due to the increasing deficit of affordable housing. During EJC engagement, we learned that environmental injustices are directly harming the health of many already disadvantaged residents.

For all our communities in Clark County to thrive we need to build a solid foundation with this Comprehensive Plan. Continued delay in meeting the deadline will only prolong and deepen the disproportionate burdens faced by vulnerable members of our communities. Councilmembers, it's important to consider how the BIPOC community feels unheard in decisions like the agricultural land study. We hope you can see this from our perspective and incorporate our needs into your decision-making.
