Public testimony by Jude Wait for Sept 24 Ag Advisory Commission Meeting.

In part, Responding to the August notes:

"a new proposed criteria for designating agricultural lands and will come back to this group for input before it goes to Counil for adoption." But without that being shared ahead of time...

Recommendations—if we are to actualize our caring about the future of agricultural production in Clark County. Can we help mitigate <u>cumulative effects</u> of NOT having had protective, promotional, supportive policies – farmland loss, farm and food related industry employment loss, high farm turnover, agricultural infrastructure loss, agroecosystem fragmentation, etc?

Farmland Designation.

- 1. Produce a Map of land under agricultural production NOW–to prioritize inclusion in "designation"
- 2. Consider that the "significance" of land includes recently and historical used for agriculture for inclusion.
- 3. Reverse the "policy" of UGAs as sacrifice areas—even as agricultural production persists, and certainly the "infrastructure" to support the agricultural sector is tied to UGAs and Cities.
- 4. Realize that "long-term significance" DEPENDS on getting the support and policies favorable to agriculture
- 5. Realize that "Agricultural lands that are not already characterized by urban growth" is largely NOT applicable to sprawling Clark County.
- 6. Consider this: IS the land CAPABLE of agricultural production?? For example, we have productive ridge-top farms, producers use "urban" agriculture farming techniques.
- 7. Map / Identify ASSETS for farming, agriculture, marketing, production, aggregation, distribution, ETC. For examples:
 - a. Include Clark College-farmland and agroecology program
 - b. WSU Vancouver-Indigenous gardens
 - c. Heritage Farm
 - d. What other land could be used for "community farm" and farm incubator approaches?
 - e. Promote and incentive collaboration, cooperation, and overcome the silos that prevent us from collective impact.
- 8. What are scientifically valid soil indicators to use?
 - a. Note that soil health can be cultivated.
 - b. Use the concept of soil resilience and farm resilience.

c. Soil classifications and designations only BEGIN to inform us of agricultural production capacity.

- (2) In carrying out its duties under this section, the department shall consult with interested parties, including but not limited to: (a) Representatives of cities; (b) representatives of counties; (c) representatives of developers; (d) representatives of builders; (e) representatives of owners of agricultural lands, forestlands, and mining lands; (f) representatives of local economic development officials; (g) representatives of environmental organizations; (h) representatives of special districts; (i) representatives of the governor's office and federal and state agencies; and (j) representatives of Indian tribes. In addition to the consultation required under this subsection, the department shall conduct public hearings in the various regions of the state.
